With regard to the South Coast Air Quality Management District ( **SCAQMD**), if your completed report and applicable fees are received at the SCAQMD by the deadline, you may be subject to late payment surcharges, which would be calculated based on the original report submittal deadline of **March 3** as specified in Rule 301(e). **April 10** is the reporting deadline for facilities and suppliers of fuels and carbon dioxide, except when subject to abbreviated reporting (applies to electricity generation facilities, refineries, cement plants, facilities producing over 25,000 metric tons of CO<sub>2</sub>e from combustion sources, suppliers, and others.*

**California’s Safe Drinking Water Act (SDWA, aka Proposition 65)**

*Proposition 65 requires employer notification at all times alerting employees to any exposure to carcinogen, mutagens, and teratogens in the workplace. This regulates 730 chemical hazards known to cause cancer, cause genetic damage, and/or cause damage to the fetus of an unborn child, i.e., birth defects. Such hazards must be included as a part of occupational safety and health training for employees.*

*NOTE: California facilities must electronically submit an annual report to the Storm Water Multiple Application and Report Tracking System (SMARTS) Database by July 15 annually. The deadline for the Construction General Permit is September 1 annually. The annual fee for No Exposure Certification is \$150 with the deadline for recertification October 1 annually. Discharges from the 10 categories of industries are listed in the Federal Register (40 CFR 122.26) and the discharges from construction disturbances of 1 acre or more.*

**Qualified Industrial Stormwater Practitioner (QISP)** The California Stormwater Industrial General Permit (IGP) glossary defines a Qualified Industrial Stormwater Practitioner (QISP) as: “Only required once a Discharger reaches Level 1 status, a QISP is the individual assigned to ensure compliance with this General Permit or to assist New Dischargers with determining coverage eligibility for discharges to an impaired water body. A QISP’s responsibilities include implementing the SWPPP, performing the Annual Comprehensive Facility Compliance Evaluation (Annual Evaluation), assisting in the preparation of Annual Reports, performing ERAs, and training appropriate Pollution Prevention Team members. The individual must take the appropriate State-approved or sponsored training to be qualified. Dischargers shall ensure that the designated QISP is geographically located in an area where they will be able to adequately perform the permit requirements at all of the facilities they represent.”
